The University of California Office of the President has rolled out the online program, which will satisfy the mandatory 2 hour sexual harassment prevention training requirement for supervisors, faculty and all academic appointees. ### KNICKS COACH COMMITS FLAGRANT FOUL

On October 2, 2007, a jury found that New York Knicks coach Isiah Thomas sexually harassed former Knicks executive, Anucha Browne Sanders. When Ms. Sanders complained about the harassment, she was fired. The jury decided that Madison Square Garden and its chairman, James Dolan, must pay the plaintiff \$11.6 million in damages for allowing a hostile work environment and for retaliation. In California, individuals may be held personally liable for sexually harassing co-workers. Also, retaliation is one of the fastest growing legal claims and is among one of the top three types of employment discrimination complaints made to the Equal Employment Opportunity Commission (EEOC).

# SO YOU THINK YOU CAN DANCE

An honors student at Northeastern Illinois University was disciplined for touching the breast of a classmate during a dance class. The student admitted that he held a metal hoop next to his classmate and said "This will fit you." He then tried to place the hoop around her breast. Not only was the student found to have violated the university's sexual harassment policy, but he was criminally prosecuted by the Cook County District Attorney's Office. A 2006 survey released by the American Association of University Women found that the majority of college students who engaged in sexually harassing behavior did so because they "thought it was funny." Horseplay, pantsing, pinching and other physical behavior done in jest could create a hostile environment.

# DID YOU KNOW ...?

Last August, Venus Williams won her fourth Wimbledon women's singles title. She is in an elite group of female athletes who have accomplished this feat including Billie Jean King, Martina Navratilova, and Steffi Graf. For the first time in the history of Wimbledon, the women's singles prize of \$1.4 million was equal to the men's prize. Finally, gender equity comes to Wimbledon after 123 years!
