## LAST CHANCE FOR SEXUAL HARASSMENT PREVENTION TRAINING IN 2011

### ANNUAL CLERY CAMPUS SECURITY REQUIREMENTS

The news reports of sexual assault allegations at Penn State have sometimes mentioned possible "Clery Act" violations. The Annual Clery Campus Security Report provides statistics on specified crimes reported over the previous three years which occurred on campus, in off campus buildings or property owned or controlled by the University, or on public property adjacent to campus. The report also contains information pertaining to campus security, alcohol and drug policies, sexual assault prevention and response, missing person reports, victims' assistance programs, crime prevention and campus resources. <u>All members of the campus community are encouraged to report crimes to the UCSD Police Department at (858)</u> 534-4357. Emergencies or situations that may pose an immediate or ongoing threat to the health and safety of our students, employees and visitors should immediately be reported by dialing 911 from a campus phone or pay phone, by dialing (858) 534-HELP(4357) from a cell phone, or by using one of the call boxes located in the parking areas. ## FORMER LIFEGUARD WINS SEX DISCRIMINATION CASE

On November 22, 2011, a federal jury decided in favor of a female lifeguard who sued the City of San Diego for sex discrimination. Plaintiff Alison Terry successfully argued that the reason she was repeatedly passed over for a promotion was because of the city's lifeguard service practices that discriminated against women. After 14 years of working as a seasonal lifeguard, she quit after being rejected for a full time position. Terry is the fifth female lifeguard to sue the City of San Diego and the first to win a jury verdict. She was awarded \$100,000 in damages.
